


RGGI Background

- Started in 2009, RGGI is the first market-based, cap-and-invest program in the nation.
- The purpose of this cooperative effort among 11 eastern states is to reduce carbon dioxide (CO_2) emissions from power plants.
- Each state has independent regulations for their individual CO₂
 Budget Trading Program based on the RGGI Model Rule.
- RI Statute & Regulations
 - RIGL § 23-82: Implementation of the Regional Greenhouse Gas Initiative Act
 - Air Pollution Control Regulation #46:
 "CO₂ Budget Trading Program" and #47 'CO₂ Budget Trading Program Allowance Distribution' (Auction portion of regulations)





How RGGI Works



RGGI States establish a regional cap on CO₂ emissions which declines over time.



Power plants must purchase enough RGGI allowances at quarterly auctions to cover their CO₂ emissions.



RGGI States invest the proceeds from auctions back into their communities to fund clean energy programs, energy efficiency, renewable energy and bill assistance.

Agency Roles & RGGI Inc.

RIDEM, Office of Air Resources

- Responsible for RGGI rulemaking
- Issues RI CO₂ allowances
- Oversees compliance

RI Office of Energy Resources

- Allocate RGGI proceeds including the EC4 spending plans
- Distribute RGGI proceeds to RGGI funded programs across state agencies
- Proceeds reporting


RGGI Inc.

Provides RGGI states with technical & administrative services and works as an agent on behalf of the states with various contractors.

- The RGGI Inc. Board of Directors is comprised of 2 agency heads from each state.




RGGI-wide CO₂ Emissions Reduction

How we distribute auction proceeds


- Proceeds are distributed and allocated in accordance with RIGL § 23-82-6
 - Promotion of energy efficiency
 - Promotion of renewable energy technologies
 - Direct rate relief
 - Auctions yielding more than \$4.5 M shall transfer the excess up to \$1.5 M to OER on behalf of the EC4 (started in FY24)
- Allocation Plans outline how proceeds will be invested
 - Issue 2 to 4 allocation plans a year
 - Draft plan is typically posted 2 to 3 weeks after last auction

Invested a total of \$18,117,603.33






RI 2023 Investment of Proceeds

Investment Highlights

- Home Electrification and Appliance Rebate Program, \$4 M
 - Provides rebates to help households save money on select home improvement projects and lower energy bills
 - Launched September 2024
- Renewable Energy Fund, \$2.56 M
 - funded several of their programs including the small-scale and commercial-scale PV programs, brownfields solar PV program, and the development of renewables on carports.
- 56% of RGGI funds allocated in 2023 will flow to disadvantaged communities and low-and moderate-income households via the following programs:
 - Direct bill assistance
 - Lead by Example School Lighting Program
 - Residential and Commercial low- and moderate- income solar grant program
