OER	\$1.1 Million	EV and E-Bike Incentives programs	This funding will support continuation of both the DRIVE EV program and E-Bike incentive program
Commerce	\$200,000	Dialogue with the business community	Commerce will bring on contractual support to provide direct outreach and support for the business community to navigate various incentive programs and implement practices to achieve GHG reductions and resilience measures.
Statewide Planning	\$100,000	Climate Vulnerability Assessments	The Climate Resilience Technical Assistance Program will work with towns to review municipal regulations and identify areas for improvement to promote climate resilience. This will add to funding already identified by the Office of Statewide Planning.
DEM	\$100,000	Programmatic work for Chief Resilience Officer	This funding will support implementation of work developed by the Chief Resilience Officer.
PUC	\$150,000	Contractual staff for AOC implementation	The PUC will add a contract employee to work as part of the policy team on dockets that relate to implementation of the Act on Climate. This contractor will also assist in keeping the EC4, Advisory Board and STAB informed of the progress on these dockets.
RIDOH	\$80,000	Investigation of flooding risk and contamination	The Environmental Health Risk Assessment Program will develop tools to examine the intersection of chemical contamination, flooding, and cancer. This work will make it easier for RIDOH to investigate community cancer concerns and will build community capacity to respond to environmental exposures due to flooding. They will develop two versions of a GIS tool to integrate existing cancer incidence, historic site use, and flood risk data, and will use the tools to educate community members.
DEM	\$100,000	AmeriCorps members to support climate justice	DEM will hire two AmeriCorps members to work across programs and with local community-based organizations to support climate and environmental justice projects.
DLT	\$70,000	Environmental education and workforce grant program	The Department of Labor and Training will create a small grant program that focuses on environmental education, professional development, and youth apprenticeships or internships.
DEM	\$100,000	Investments in urban tree cover and improving growing sites	The Urban and Community Forestry Program will use this funding to increase tree survivability by preparing and improving growing sites. This

			will supplement federal funds that provide technical assistance to towns for implementing urban tree projects.
RIIB	\$150,000	Additional investment in Energy Asset Management Program	This will add funds to the RIIB Energy Asset Management Program for additional technical assistance to towns, school districts, and publicly owned utilities.
OER	\$150,000	Support for municipal participation in state energy programs	OER will use this funding to support municipal participation in state energy programs and help leverage funding for municipal project implementation
TBD	\$100,000	Contractual support to prepare and develop federal grant applications for climate programs	Funds will be available to agencies when requested for support to prepare and develop federal grant applications related to climate programs.
TBD	\$200,000	Support for incorporating climate change considerations into public building investments	Funds will be available when requested to agencies (RIDE, Housing, EOHHHS) to provide assistance for evaluating feasibility and design for net-zero building enhancements on public buildings.
